### Ruapehu Report

The lodge has got off to a solid start for the winter season, with a booking from Tihoi Venture School in June bringing in \$2700, and 60 bed nights booked so far for the July school holidays, traditionally a quiet time for us.

We have renewed the lodge insurance, choosing this year to go with an indemnity only policy (an agreed

sum) plus an add-on to cover the demolition insurance that we are required to have under the terms of our licence from DOC. Insurance is under constant review by the Ruapehu committee, and in the last 10 years we have moved between full cover and indemnity only, depending on the price. We are being cautious this year given the high cost of living and uncertainty around RAL, which may affect bookings at the lodge.
